## La Crete, Ft. Vermilion & High Level Tour



On June 11, the MPWA held a board meeting in Manning. Nora Paulovich, from NPARA joined our group to advise us of the progress towards a local watershed group for the Notikewin River, a tributary of the Peace River. Following the meeting, those members of the Board that were able to, began our first MPWA Tour.

The purpose of the tour was to get a better understanding of the people and challenges faced in the northern area of the watershed and to introduce the MPWA to the public.

On our way Northward, we did a quick driving tour through Paddle Prairie Metis Settlement. Then as we continued our journey, we were entertained by various board members who shared their knowledge of the area.

The original plan was to cross the ferry at Tomkins Landing and meet the La Crete Chamber of Commerce for supper. The ferry crossing was closed due to high water and debris in the river which necessitated us traveling through High Level and Fort Vermillion. This detour put us approximately 1 hour behind schedule; however the Chamber waited and had supper with us in La Crete. Conversation evolved around water sources and issues in the area. La Crete is growing very quickly and like other quickly growing communities has issues with water quantity. Water quality does not seem to be an issue at this time however because the water source is water wells in close proximity to the Peace River, it is recognized that protection of the Peace River is imperative. The chamber gave us a quick tour of the area, showing us the recreation spots, new subdivisions and old subdivisions.



We retired to the hotel at about 9:00 pm. In the morning, the MPWA had breakfast and travelled to Fort Vermilion There, we began our visit with a trip to the Mackenzie County Chambers. We met briefly with the councilors and introduced the MPWA. Issues were briefly discussed prior to meeting with the museum curator. At the museum, we were given a history lesson on the settlement of the Northern portion of our watershed and the historical importance of the Mighty Peace as a highway. This was important because it gave us an insight into the determination of the original fur traders and settlers. We were then treated to a bus tour of the area showcasing the Agricultural Farm and the sights of the original missions, both Anglican and Catholic. We also visited the 'Old Bay House', an historical building overlooking the Peace River, that was being restored to its former elegance.

Following our visit to Fort Vermilion, we met with representatives of the High Level Town Council for lunch. They regaled us with stories of the boom and bust eras of the area. We also viewed new subdivisions, large industrial sites and the miles of swamp that surrounds the area.

A huge thank you to all those that took the time to meet with the board and share their vast knowledge of the area!

## CURRENT PROJECTS

### PROJECT UPDATE:

The MPWA has wrapped up 4 projects that were started in the 2011 year. The complete project reports can be found on our website for anyone who wishes to review them. The projects are: [Directory of Water Organizations and Agencies](#), [State of Drinking Water](#), [Current & Future Water Uses and Issues](#), and [Aquatic Ecosystem Health](#).

These reports form part of the initial stages of information gathering as the board works towards developing a better understanding of the Peace River Watershed and produce a State of the Watershed Report.

The projects for the 2012/2013 year are:

**Issue scoping and Project Synthesis** – this is a chance to review the 4 completed science projects and then determine information gaps, priorities, and recommendations. Part of the project will be to produce an online survey to assist in gathering further information from the residents and stakeholders of the watershed.

**Public Engagement Forums** – two-fold purpose to first introduce the MPWA (its goals, work, and scope) and second to listen to the residents and stakeholders to hear about the oral knowledge, issues, concerns, possibilities, and challenges around water and the watershed.

**Wapiti River Water Management Plan** – the MPWA will assist with the public consultation portion of the management plan preparation.

## THE CHALLENGES OF FUNDING



The struggle to fund our organization in a timely and effective manner continues. This our second year of operations, began using funds carried over from our first year. These funds were available because we did not hire a second individual as originally projected in our first budget. Our core operating funds for this year were received early August, which is about a week later than last year. The fact that our budget year begins April 1<sup>st</sup>, this would have meant that without the carryover from last year we would have had to close our offices from April 1<sup>st</sup> until August 5<sup>th</sup>. This would have effectively made us an organization operating 8 months of the year.

We are actively pursuing other ways of funding this organization with dollars outside the ESRD budget cycle. We are pleased that several municipal governments and two industry partners have contributed financially and that we have many others who contribute to the work of the organization through in-kind support. Many organizations have contributed 100's of hours of in-kind support which includes paying for their employees time on the board and committees (communications, technical, finance, and executive), the employees travel to meetings, provision of meeting space, and lunches for board meetings.

The volunteer board of the MPWA has taken on this Water Act mandated work. It is necessary to have timely and effective funding to accomplish our goals. We would appreciate any assistance that you as individuals, organizations, businesses, governments, and stakeholders could provide to help us find ways to meet our obligations and access appropriate funding in a timely and consistent manner.
